REFERENCE AND ADMINISTRATIVE DETAILS

The directors present their annual report and financial statements for the year ended 31 March 2015. The directors have adopted the provisions of the Statement of Recommended Practice (SORP) Accounting and Reporting by Charities (revised 2005), and the Companies Act 2006.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The charity is a company limited by guarantee and is constituted by its Memorandum and Articles of Association. It is governed by a Board of Directors, of not less than 3 and not more than 16, who meet at least quarterly.

Directors are appointed by the Board ensuring that the appropriate skills mix is available to the Board to effectively govern the company. Prospective directors are provided with details of the company and have the opportunity to meet with the Principal Officer prior to appointment. On appointment, new directors are issued with a Handbook which provides guidelines on the governance of the company and the role of the director in that. The skills of directors are identified which may result in his/her appointment to one of the sub-committees reporting to the Board. Directors are encouraged to attend various forums and events run by the company for Partnership members.

The purpose of the Board is to govern the Scotland Malawi Partnership and to ensure that the Scotland Malawi Partnership meets its stated objectives. The Board takes responsibility for giving direction to the company, ensuring that there is a framework for accountability, adopting and reviewing all systems and methods of control, financial and otherwise, monitoring people, resources and performance and for ensuring that the Scotland Malawi Partnership is complying with all aspects of the law, relevant regulations and good practice.

The directors delegate responsibility for day-to-day operations and management to the Partnership's staff. Board Committees assist the Board to meet its objectives, and include a Policy and Strategy Committee which has developed a three-year Strategic Plan to govern the work and direction of the company until April 2017, and an Audit and Finance Committee to monitor financial control, planning and reporting, and to oversee the preparation of financial statements.

OBJECTIVES AND ACTIVITIES

The SMP is the national umbrella network for Scottish organisations and individuals involved with Malawi. SMP membership is diverse, consisting of schools, colleges, universities, umbrella organisations, international development organisations, businesses, community organisations and individuals.

a) Our Vision:

The SMP exists to inspire the people and organisations of Scotland to be involved with Malawi in an informed, coordinated and effective way, to the benefit of both nations.

The Partnership promotes a people-to-people model of development, built on dignified partnership and rooted in the shared history between our two countries. It focuses on active relationships between people to foster a shared understanding of the development challenges facing Malawi and to support the development of practical, sustainable solutions. It is through this deeper understanding and shared human experience that the people of Scotland and Malawi will be able to effect real and lasting change, both through their own activity and by influencing the policies and actions of governments and institutions.

b) Our Mission:

We aim to foster links, consistent with our values, between the two nations, and encourage development of sustainable projects in Malawi by:

- informing and inspiring civil society in Scotland about the work of the Partnership, the unique shared history between Scotland and Malawi, and the development challenges facing Malawi, in order to increase public support for extending and enriching the relationship between the two nations;
- seeking to employ an alternative model of international development, based on mutually beneficial civil society partnerships and links, and advocating its wider employment elsewhere;
- acting as a forum for encouraging best practice amongst member organisations through the provision of training and the sharing of ideas, processes and information;

- encouraging a reduction in the duplication of effort in Malawi by facilitating networking, promoting shared learning and raising awareness of existing initiatives;
- developing support mechanisms which can lead to an exchange of people and/or advance cultural, political or economic understanding between Scotland and Malawi; informing our members of activities, opportunities or items of significance arising in either Scotland or Malawi;
- demonstrating the relevance of Scotland's civil society contribution to the attainment of the Government of Malawi's Growth and Development Strategy and the Millennium Development Goals.

c) **Our values:**

Our values describe our approach, and our vision and mission can only be achieved if staff, directors, member organisations and associate members hold these values:

- **Mutual Respect:** we recognise that the historic bilateral civil society relationship between Scotland and Malawi is built on trust and mutual respect and we celebrate its inherent reciprocity;
- **Cooperation:** we foster a spirit of cooperation, building partnerships and alliances in pursuit of our objectives, avoiding duplication and forging creative ways to work together;
- **Internationalism:** we stand in the tradition of Scottish internationalism, resisting isolationism and xenophobia, believing that Scotland's strength lies in building strong relationships with nations elsewhere in the world;
- **Service:** paramount in all our work is provision of the highest possible quality of service to our members. We strive to meet their expressed needs by offering relevant information, advice, training and resources;
- **Continuous Improvement:** we continuously strive to improve the quality of our service, as perceived by our members, to encourage viable, ethical development activity between our members and their Malawian counterparts;
- **Sector Understanding:** we understand the sector(s) in which our members are operating, both in Scotland and Malawi, and respond positively to situations which can advance developmental aspects of the Partnership;
- **Development:** staff, directors and members are committed to encouraging links between Scotland and Malawi, to reduce poverty, promote justice and relieve suffering in Malawi. To achieve that, we all have a role to play in managing our own development and in being supportive of others.

ACHIEVEMENT AND PERFORMANCE

2014-17 Strategic Plan

In 2014-15 the SMP successfully completed the first year of its ambitious 2014-17 Strategic Plan, with its four core strands of activity:

- **Strand one**, entitled "**SOWING THE SEEDS by raising awareness and inspiring others**", which sees the SMP further develop its website, media engagement and research demonstrating impact, and seek new and exciting ways of helping members share their own stories of membership engagement.
- **Strand two**, entitled "**NURTURING NEW GROWTH in priority areas**", sees the SMP invest further in: business, trade and tourism; youth and schools engagement; the Malawi Scotland Partnership (MaSP); Local authority engagement; diaspora engagement; and the Glasgow Commonwealth Games.
- **Strand three**, entitled "**INCREASING OUR YIELD by strengthening existing links**", sees the SMP: continue to disseminate information to members; increase training and mentoring; support best practice, sustainability and transparency; continue to facilitate member forums; offer practical advice, support and funding assistance; deliver specific campaigns and projects; issue SMP publications; and support networking.
- **Strand four**, entitled "**SHARING OUR PRODUCE by connecting with & influencing others**", sees the SMP continue its lobbying and advocacy work, its support for MaSP, its engagements with the governments of Scotland, the UK and Malawi, and its partnering across Scotland, Malawi and the UK.

Activities in 2014-15

In 2014-15 the SMP hosted 31 events/engagements attended by a total of 1,063 people, including 13 Member Forums attended by 281 people and four Cross Party Group meeting attended by 114 people. We also supported/co-hosted a further 26 events/engagements attended by an estimated 2,200 people.

ACHIEVEMENT AND PERFORMANCE

We have continued to work with our sister organisation Malawi Scotland Partnership (MaSP) and in recognition of this unique relationship we have this year modified our accounts to reflect specific MaSP funding.

Key activities in this period included:

April 2014:

- Supported Scottish Parliament Debate on International Development and the Scottish Government's work with Malawi.
- Recruited three new staff members: Keith Bohannon, Member Development Officer; Jackie Farr, Media and Communications Officer; and Caroline Beaton, Youth and Schools Officer.
- Furnished and equipped a third office for the SMP within the Edinburgh City Chambers, with all furniture donated by the City of Edinburgh Council.
- Co-hosted review of the Scottish Government's small Grants Programme

May 2014:

- Kept members informed through the tripartite elections in Malawi and, after the election, re-established contact with the new President, Vice President, Minister for Foreign Affairs and the Minister for Health.

June 2014:

- Co-hosted a major conference with Education Scotland, bringing together 90 Scottish primary and secondary schools with links to Malawi.
- Facilitated a meeting of the Malawi Cross Party Group in the Scottish Parliament giving post-election analysis with input from the Government of Malawi and the University of Edinburgh.
- Launched SMP's Governance Forum bringing together 20 key members engaged in governance projects, connecting with the Scottish Government and DFID, and beginning an SMP mapping exercise of all major governance projects in Malawi across all donors.
- Supported the Inspire>Aspire National Awards Ceremony at the University of Glasgow, attended by over 500 school pupils from across Scotland who were engaged in this educational project linked to the Glasgow Commonwealth Games. The SMP and MaSP had been working for the previous 6 months to support schools in Scotland linked to Malawi to use the Inspire>Aspire project to learn more about their friends in Malawi, and visa and versa.
- Supported "Celebrating Africa 2014" hosted by Edinburgh and Lothians Regional Equality Council (ELREC), helping build links with other African communities in Edinburgh and showcasing the work of the partnership, and its engagement with the Malawian diaspora in Scotland.
- Hosted a meeting of the SMP Health Links Members' Forum, attended by 23 organisations, looking at best practice when donating medical items to Malawi, shared lessons in partnership, and new funding opportunities.
- Hosted a meeting of the SMP Business, Investment, Trade and Tourism Forum, attended by 24 SMP members, representing NGOs, business and government.
- Arranged meeting with Scottish Government Minister for International Development and returned healthcare volunteers, lobbying for greater support for NHS staff to volunteer internationally.
- Hosted a roundtable meeting for members to meet the UK Minister for International Development Lynne Featherstone MP, incoming Head of DFID Malawi (Jen Marshall), and the Scotland Office.

July 2014:

- In the two weeks in the run up to Malawi's 50th anniversary of independence, the SMP published online five serialised video interviews with Colin Cameron, talking about his key involvement in the run up to Malawian independence in 1964.
- On the 6th July the SMP unveiled Scotland's 50th birthday card to Malawi: the "50 stories for 50 years" micro-website created by the SMP. Over the previous four months the SMP had been working with the 50 "special ambassadors" to create 50 x 50-second videos or 50-word stories on Scotland-Malawi links. At the same time, the SMP unveiled 50 Malawian flags flown across Scotland on prominent public buildings.
- Hosted the national celebrations to mark the 50th Anniversary of Malawi Independence, with members of the Malawian Diaspora. More than 150 Malawians from across Scotland attended the celebrations which included the first ever performance of the Black Missionaries (Malawi's most successful band) in Scotland.
- The SMP worked to ensure that Malawi was the first nation to be welcomed into the Athletes Village for the Commonwealth Games, and the first to have its flag-raising ceremony. The SMP was also active troubleshooting as issues arose throughout the Games.

ACHIEVEMENT AND PERFORMANCE

- With the Scottish Government and UNICEF, organised and funded a visit by Monica Dzonzi (Malawi UNICEF Youth Ambassador) to Scotland for the Glasgow Commonwealth Games. Together, more than 20 events and activities were scheduled as part of her visit, each one celebrating and raising awareness of the links between Scotland and Malawi.
- Supported a special Scotland-Malawi music concert as part of the Commonwealth Game attended by around 300 people.
- Hosted a "Pop-Up Malawi House" as part of the Commonwealth Games event, supporting Team Malawi and presenting Malawi in a positive light in the Scottish media.
- Organised a number of events around the Scotland-Malawi netball game during the Commonwealth Games including a post-match photo op with both teams for the media and a special free viewing event, where members and the public could watch the event live.
- Co-organised a special visit to the David Livingstone Centre for Team Malawi, including a sports day for the local schools with Malawi links.
- Supported the Scottish Government's grant-holder event, attended by around 70 key delegates.
- Co-hosted information half-days for the second round of the Small Grants Programme in Edinburgh and Glasgow.

August 2014:

- Supported a debate in the Scottish Parliament on "Scotland and Malawi, A Special Relationship".
- Supported the Scottish Government's Malawi Development Programme information day, including the production and presentation of a special new SMP publication "Common Challenges, Shared Learning", which shared learning from past work, to assist with the development of new projects and partnerships.

September 2014:

- Recruited Emily Mnyayi, the SMP's new Youth and Schools Officer.
- Organised a week of meetings and engagements for Dr Matthews Mtumbuka in advance of his attendance at the SMP AGM.
- Facilitated the Malawi Cross Party Group's Annual General Meeting, attended by 40 MSPs and members.
- Supported international health students from Dundee University visiting Malawi.
- Hosted a Malawi stall at the Scottish Learning Festival, giving out free information and education resources to hundreds of primary and secondary teachers, and hosting a special Malawi seminar with the Scottish Minister for Education and Lifelong Learning.
- Hosted the SMP's 2014 AGM: our biggest and best to date. Themed around "together in the talking place", all activities took place around a "campfire" on stage. 110 Members attended the day and feedback was outstanding with 94% rating the AGM as "excellent" or "very good".

October 2014:

- Hosted SMP Business, Investment, Trade and Tourism Members' Forum, supporting and coordinating member activity.
- Presented at the annual meetings of the Blantyre Fellowship - a group of Scots and Malawians that used to live in Malawi which has been active for more than 40 years.
- Hosted meeting of the SMP Health Forum discussing partnership principles in action.

November 2014:

- Co-hosted a screening of the Malawian film B'ella, as part of the Africa in Motion festival, for youth SMP members with direct input from the film's Director and a live panel discussion.
- Gave a lecture to The University of Glasgow's Glasgow Centre for International Development (GCID) about Scotland-Malawi links and the SMP.
- Hosted SMP Governance Forum meeting with input from Local Councillors in Malawi and the University of Dundee.
- Spoke at the University of Strathclyde's Fashion Show raising funds for Malawi, attended by around 300 people.
- Keith Bohannon, SMP Member Development Officer, visited Malawi to help open GALVmed's new Centre for tick-borne diseases, and meet with representatives from across Malawi (from key ministries to small-holder farmers) to develop the SMP's support for Scotland-Malawi business and trade links.

ACHIEVEMENT AND PERFORMANCE

December 2014:

- Hosted Further and Higher Education Forum meeting with input from DFID, the CEO of the National Council for Higher Education in Malawi, and the VC of Mzuzu University.
- Hosted event for members to meet with the Malawian Minister for Foreign Affairs and International Cooperation, attended by 72 members.

January 2015:

- Hosted SMP Youth Forum Meeting engaging and listening to SMP youth members.
- Hosted SMP Business, Investment, Trade and Tourism Members' Forum, discussing how development projects can build, not undermine,
- Responded to the severe flooding which affected much of Malawi in January 2015: coordinating members' work, disseminating news from Malawi, and supporting a prompt and effective governmental responses. The SMP was able to help expedite the Scottish Government's response to the flooding by being an intermediary for six mini emergency grants to Scottish organisations responding to the floods.

February 2015:

- Co-hosted "Chilembwe Revisted" conference, marking the centenary of the Chilembwe uprising, an important historical event and a key moment in the developing Scotland-Malawi links.
- Hosted SMP Health Forum looking at responses to the floods and disseminating recent health research findings from Malawi.
- Facilitated meeting of the Malawi Cross Party Group, at which two new Co-Conveners were elected to lead the group (Michael Russell MSP and Liam McArthur MSP), and at which MSPs were briefed on Scotland's response to the floods in Malawi.
- Delivered a media training day to help develop the SMP's capacity to tell its story in the mainstream media.
- Delivered two Chichewa Language classes in Edinburgh and Glasgow, with cultural familiarisation briefings for those visiting Malawi from members of the diaspora community.
- Hosted SMP's Primary and Secondary Schools Forum attended by 29 people schools and teachers.
- Gave a lecture on Scotland-Malawi links as part of the University of Edinburgh's Africa and International Development Masters course.

March 2015:

- Co-hosted a new Climate Justice networking forum, bringing together organisations funded by the Scottish Government's Climate Justice Fund.
- Hosted SMP Governance Forum looking at 'cashgate' in Malawi, with briefings by the Director of the Cambridge Governance Labs.
- As part of Fair Trade Fortnight, hosted a special Fair Trade Lunch showing the Fair Trade Forum's latest film about Malawi tea and sugar growers, and at which Mr Charles Chavi (representative of Malawian small-holder sugar cane farmers) spoke. Mr Chavi raised the issue of the change in the EU sugar cane cap and, within a month, the SMP had a commitment from 4 of Scotland's 6 MEPs to represent this issue, and the topic was then debated in the European Parliament.
- Hosted SMP Youth Forum.
- Supported DFID Ebola briefing with the Secretary of State for Scotland and Baroness Northover.
- Supported a roundtable meeting with Secretary of State for Scotland and Baroness Northover launching DFID's new Disability Framework.
- Spoke at the Asia-Scotland Institute's 'Building Bridges' conference at the Royal Bank of Scotland, representing Scotland-Malawi links.
- Supported the visit of Monica Dzonzi, UNICEF Youth Ambassador to Malawi, back to Scotland as part of various events around International Women's Day.

ACHIEVEMENT AND PERFORMANCE

Strategic priorities in 2014-15

Business, Investment, Trade and Tourism

The SMP launched its Business, Trade, Investment and Tourism (BITT) Members Forum, and had three very successful meetings in 2014-15, attended by 62 people. The SMP has built Scottish markets for Malawian exports, most notably Mzuzu coffee and Kilobero Rice, through significant marketing and engagement campaigns which have, for example, seen an 83% increase in Malawian coffee sales in Scotland. It has also supported investment into Malawi against Malawian priorities and helped develop Malawi tourism through strategic partnerships with, for example, Kenyan Airways, the Malawi Tourist Board, the Lake of Stars festival, and key tour operators in Malawi. Following Malawian priorities, it also commissioned a listening exercise by the University of Dundee exploring Scotland-Malawi collaboration in the extractive industries. The SMP continues to make a significant contribution to the sustainable economic development of Malawi.

Lobbying and Advocacy

In 2014-15 the SMP facilitated four meetings of the Scottish Parliament's Malawi Cross Party Group, attended by 114 people, and helped support the UK Parliament's All-Party Parliamentary Group on Malawi and Zambia. The Partnership also supported two debates in the Scottish Parliament, which had unanimous support for Scotland's links with Malawi, and facilitated various questions and debates in the House of Commons and the House of Lords, advancing the advocacy priorities of Members. The Partnership has been successful in maintaining strong, unambiguous cross party political support for its work and its members' activities, providing regular briefings and meetings with MSPs, MPs, Peers and Ministers. Through 2014 the SMP was active in the Scottish independence debate: while maintaining studiously neutral itself, it was able to represent members' interests, ensuring Scotland's links with Malawi were not lost from either the debate before the referendum or the Smith Commission afterwards.

Communications and Media

In 2014-15 there were 130 pieces in the Scottish media (TV, radio, print and online) about the links between Scotland and Malawi, 60 of which were led by, or featured, the SMP and all of which were positive. With its new Media and Communications Officer, the SMP is now able to commit significantly greater time and resource to supporting such coverage and engagement: it has also built its capacity through bespoke media training. On social media, the SMP saw a growth of 112% in Facebook likes and a 106% increase in Twitter followers, and created SMP accounts with LinkedIn and Instagram. Significant time was committed in 2014-15 to the development of the new SMP website which will be launched in July 2015.

Youth and Schools

The recruitment of the dedicated Youth and Schools Officer considerably increased the SMP's capacity to support youth engagements. Its new Youth Forum has helped drive forwards the Partnership's work in this area from a youth-led perspective. Five youth newsletters were sent out in 2014-15 to the SMP's youth members, giving information and advice to 172 subscribers - young Scots engaged in the civic links with Malawi. At the start of the year the SMP had a record Scotland-Malawi Youth Congress, with all 200 places selling out months in advance. A total of 23 new schools have joined the SMP in this year and the Partnership has delivered engagements in dozens of schools right across Scotland. In addition, the Partnership has helped broker five new school to school links with Malawi and the SMP's updated Practical Guide for School Partnerships has been downloaded more than 100 times.

Glasgow Commonwealth Games

The SMP was actively involved in the 2014 Glasgow Commonwealth Games, supporting Team Malawi and presenting a hugely positive image of Malawi to Scotland and the world. We did this by:

- Supporting the Queen's Baton Relay while in Malawi, which coincided with Burns Night, ensuring there was a strong Scottish focus.
- Supporting Team Malawi at their pre-games training base in Gloucestershire.
- Ensuring Team Malawi were the first nation to be welcomed into the athletes village and the first to have its flag-raising ceremony: a special privilege reserved for one of Scotland's closest friends
- Flying Monica Dzonzi (UNICEF's Malawi Youth Ambassador and long-time friend of Scotland) to Scotland to take part in events throughout the games.
- Ensuring Malawi was the first African nation involved in UNICEF's opening ceremony fund-raising drive.
- Hosting the Pop-Up "Malawi House" to support Team Malawi and promote Malawi as a tourist destination.
- Supporting Team Malawi to visit the David Livingstone Centre in Blantyre.
- Supporting various cultural and musical events celebrating Scotland-Malawi links.

ACHIEVEMENT AND PERFORMANCE

- Supporting the donation of new bikes to Team Malawi's cyclists when it became apparent their bikes were not suitable. With generous donations from the public, and the kind support from an independent cycling shop in Glasgow, yet more bikes and parts are being donated to equip Team Malawi for many years to come.
- Supporting media coverage around the Scotland-Malawi netball game on the 29th July.

The Secretary General, Malawi Olympic Committee said:

"The Malawi Olympic Committee would like to express its profound gratitude on your commitment and all the support you rendered to Team Malawi during the time it was in Scotland. You organized for the Team all the necessary programs to make the Team feel at home away from home. The connections you made between the Ministers, the Diaspora and the Team Malawi will live a long way in the lives of Team Malawi Delegation. We did not take all the support for granted; even during the matches we felt the presence and the warmth of the People of Scotland."

Malawi 50th Anniversary

In the two weeks in the run up to Malawi's 50th anniversary of independence, the SMP published online five serialised video interviews with Colin Cameron, talking about his involvement in the run up to Malawian independence. The, on the 6th July the SMP unveiled Scotland's 50th birthday card to Malawi: the "50 stories for 50 years" micro-website created by the SMP. Over the previous four months the SMP had been working with the 50 "special ambassadors" to create 50 x 50-second videos or 50-word stories on Scotland-Malawi links. At the same time, the SMP unveiled 50 Malawian flags flown across Scotland on prominent public buildings. That weekend, the SMP hosted the national celebrations to mark the 50th Anniversary of Independence in Malawi. More than 150 Malawians from across Scotland attended the celebrations which included the first ever performance of the Black Missionaries (Malawi's most successful band) in Scotland for the SMP.

Demonstrating the scale of Malawi links

In July 2014, to welcome Team Malawi to the Glasgow Commonwealth Games, the SMP published its latest study by the University of Edinburgh on "Valuing the Links Between Scotland and Malawi". This report found that:

- 94,000 Scots are actively involved with links to Malawi (an increase of 11% since 2010);
- 198,000 Malawians are actively involved in links to Scotland (an increase of 34% since 2010);
- 300,000 Scots benefit from Malawi links each year (an increase of 7% since 2010);
- 2 million Malawians benefit from links with Scotland each year (an increase of 31% since 2010);
- SMP members contribute more than £40 million of inputs to their Malawi links annually (an increase of 33% since 2010).

In October 2014 the SMP published a Public Awareness Study, which found that:

- there is four times greater awareness in Scotland of links with Malawi than with any other African country;
- over 46% of Scots personally know someone involved with a people-to-people link with Malawi
- 74% of Scots are in favour of links with Malawi and only 3% are against.

Impact

In 2014-15:

- 92% of members felt that membership of the SMP "helped strengthen, support and develop their links with Malawi".
- 78% of members said networking at SMP forums helped improve the effectiveness of their links.
- 75% of members said the sharing and learning at the SMP's forums had helped improve the effectiveness of their partnerships with Malawi.
- 65% of members said information offered at SMP forums helped improve the effectiveness of their links.
- 56% of members reflected on how their links can support economic development in Malawi, and 30% of these have changed their way of working as a result.
- 80% of members said the SMP's language classes were "excellent" or "very good."
- 46% of members said that, as a result of the SMP's activities, they had reflected on Malawian priorities and how they could work towards these priorities, and 17% said they had changed their working as a result.
- 94% of respondents rated the 2014 AGM overall as "excellent" or "very good";

FINANCIAL REVIEW

Reserves policy

It is the policy of the Scotland Malawi Partnership to distribute its net income in support of its objects. It is anticipated that any surplus funds at the close of the year would be distributed in the following year, while retaining sufficient accumulated funds to meet expenditure commitments for between two to four months. The need for such reserves cover is restricted to SMP operations only, since it is assumed that all other grant-funded projects would be terminated in the event of the charity being wound up and any unspent funds returned to the funder after deduction of expenses. As staffing and activity levels have increased from April 2014 levels of administrative expenditure would require balances of between £30,000 and £65,000 to be retained within reserves. The actual unrestricted reserves as at 31 March 2015 were £49,179, which is within the middle level of acceptable reserves.

Financial Review

The financial statements show net outgoing resources for the year ending 31 March 2015 of £36,238 and a cash balance at 31 March 2015 of £131,056.

Key transactions in the year were:

- Receipt of a Scottish Government grant of £231,542 for the administration of the Scotland Malawi Partnership. This was the first instalment of the total grant for the next three years.
- Receipt of a Scottish Government grant of £100,000 was received for the David Livingstone Bicentenary Scholarship Programme in Malawi. The full amount of the grant was included within Incoming Resources. £88,394 including bank charges was paid out to scholars in the year with a remaining balance of £11,606 as at 31 March 2015.
- Receipt of membership subscriptions of £9,094 and unrestricted donations of £3,003 including Gift Aid payments.

STATEMENT OF TRUSTEES RESPONSIBILITIES

The trustees (who are also the directors of The Scotland Malawi Partnership for the purposes of company law) are responsible for preparing the Report of the Trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing those financial statements, the trustees are required to

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charity SORP;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charitable company and to enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The trustees are responsible for the maintenance and integrity of the corporate and financial information included on the charitable company's website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.





1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), the Companies Act 2006 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities.

Incoming resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources. Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Governance costs

Consists of the costs of the accounts preparation, costs relating to the Annual General Meeting and travel expenses for trustees to attend board meetings in compliance with the legal requirements of the charity.

Tangible fixed assets

Fixed assets costing £400 or more are capitalised at cost. Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life as follows:

Office Equipment - 33% straight line

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

10. MALAWI SCOTLAND PARTNERSHIP (MASP)

MaSP is a sister organisation to the Scotland Malawi Partnership (SMP). It is a separate legal entity, and is entirely Malawi-led with its own constitution, Board and Secretariat, based at Kamuzu College of Nursing in Lilongwe. Grant funding was provided from the Scottish Government to the Scotland Malawi Partnership for the development of MaSP. The Scotland Malawi Partnership is accountable to the Scottish Government for all funding allocated under the grant and for the delivery of the objectives and outcomes associated with the project.

These accounts include grant funded expenditure of £58,736 (2014: £93,568) incurred by the Scotland Malawi Partnership on behalf of MaSP comprising £6,036 (2014: £12,768) core costs incurred in the UK and £52,700 (2014: £80,800) funding transfers to MaSP in Malawi.

Detailed accounting for expenditure incurred in Malawi is a MaSP responsibility and does not form part of these accounts. The following table is provided purely for information and shows a breakdown of the expenditure incurred in Malawi during 2014/15 as reported by MaSP.

The expenditure is incurred and reported in Malawi Kwacha by MaSP.
An average exchange rate of 705 has been used to show the approx £ value of the expenditure.

During the year, a grant of £65,304 (2014: £58,767) was received from the Scottish Government for the development of the Malawi Scotland Partnership (MaSP). This was the final instalment of a total grant of £192,473 due over three years. The full grant was recognised in the statement of financial position in the year of the award. The grant has been shown in the MaSP restricted fund and at the year end, £6,589 (2014: £65,325) was still to be utilised, £6,589 all of which is still held in the UK.

During the year, the charity received a grant of £231,542 from the Scottish Government. The grant offered was for one year only. The grant was restricted and at the year end, £656 was still to be utilised.

In 2013, the charity received a grant of £100,000 from the Scottish Government to fund the David Livingstone Bicentenary Scholarship Programme in Malawi, and during the current year a further £100,000 was received by the charity. During the year, £88,394 (2014: £55,191) including bank charges was expended, giving 50+ underprivileged Malawi students the opportunity to study at a Malawian further or higher education institution. At the year end, the remaining fund balance was £56,415 (2014: £44,809).
